




What you need to know

Navigating your new electric bill

As a result of our recent software upgrade, your bills will soon have a new look. You will find the same important information with some new features to make managing your account even easier. We also have more room to share detailed messages with our members.



INFORMATION KEY

Account Information:

Your billing date, account number and account name are listed here.

B Important Messages: Learn about programs, ser

Learn about programs, services, notices and events.

Total Amount Due:

This section lists your total amount due and the due date. Automatic payment would be indicated here if you participate in this program.

Electric Service Description:

Details regarding your usage. Your kW demand is listed here (for informational purposes only because WCE currently does NOT charge demand on residential or small commercial accounts).

Usage Graph:

This graph lets you track your electric usage from month to month and gives the average temperature.

Charge Detail:

This section gives you a breakdown of all the charges making up your total amount due for the current billing cycle.

Energy Usage Comparison:

At-a-glance comparison of your usage.

Payment Stub:

If you are paying by check, please return this stub with your payment to ensure the payment is properly credited to your account.











As hunting season approaches, excitement builds for time outdoors. But before you head into the woods, make sure electrical safety is part of your preparation checklist.

Before you climb that tree stand, look out for power lines.

Never install a tree stand near a power line or on a utility pole. Electricity can arc through the air up to 10 feet from high-voltage lines. This means you don't even have to touch a wire to be at risk of electrocution.

Never shoot near or toward power lines, utility poles, transformers or substations. Stray bullets or pellets could damage equipment, possibly interrupting electric service. Even more concerning, they could drop a power line to the ground, causing a hazardous scenario: those who get within 50 feet of a downed line could be shocked or electrocuted.

Keep your distance. Stay at least 10 feet away from overhead lines, poles and other electrical infrastructure when setting up or taking down tree stands.

Never climb a utility pole. Even if it looks like the perfect vantage point, don't do it. Poles carry high-voltage lines, and climbing them can be deadly.

Don't use utility poles for support. Tree stands or blinds should never be attached to or supported by power poles or electrical equipment.

Watch for downed lines: Stay at least 50 feet away from downed power lines or damaged electrical equipment. Call 911 or your utility immediately.

Keep these tips in mind to stay safe:

Scout the area. Before hunting, scout your area during daylight. Look for power lines, poles and electrical equipment. Note their locations to avoid them later.

Power safely. If you're using a portable electrical generator, don't use it inside a cabin or RV, or in a confined area. Make sure it's used outside with plenty of ventilation.

Avoid aiming toward power lines or equipment. A stray bullet could knock down a line, interrupt power or create a deadly hazard.







Paying Tribute

On a gorgeous, crystal clear Saturday in September, the route from Arcadian Moon Winery in Higginsville to the Branded Steakhouse and Event Center in Richmond thundered with the growl from hundreds of motorcycles being ridden in tribute to the lives lost on 9/11.

Gail's 9/11 Tribute Ride, which was first organized shortly after the 2001 attack on America, is typically led by police officers, firefighters and the military, and honors the first responders, military personnel and all those lost on Sept. 11, 2001. The ride is a fundraiser for the Fire Fighters Memorial Foundation of Missouri. Among other things, the foundation supports the Missouri Fire Fighters Memorial and Museum in Kingdom City.

The 2025 event began on the morning of Sept. 6 with a bike blessing given by Bikers for Christ, and kickstands up at 11 a.m. The convoy passed by West Central Electric Cooperative's headquarters office in Higginsville, where 252 riders were greeted with a large American flag waving from the highest tip of a digger truck anchored near the highway.

"It was pretty cool to see all the motorcycles riding together in honor of the fallen at 9/11," WCE Operations Manager Scott Gard said. "They were waving, revving their cycles and pumping their fists when they saw the big American flag hanging high and proud on the digger truck."

Gard showed up to the office early with his two daughters, Taylor and Tyler, to ready the truck.

"It made me feel happy and proud," Tyler Gard said. "You could definitely hear the rumble of them coming down the highway!"

Taylor echoed her sister's sentiments.

"It was an awesome experience and I look forward to watching it next year," she said.

The annual ride had been on hiatus after organizer Gail Worth closed Gail's Harley-Davidson in Grandview, but returned this year, according to Grant Oetting, 2nd vice president for the Fire Fighters Association of Missouri.

"We weren't sure how many might come to Lafayette County, but they definitely came out," Oetting said. "We thought it went really well, and Gail was really happy with the turnout."

Oetting said organizers are looking at bringing the event back to Lafayette County again in 2026. Several locals had a hand in assisting with the event including Kyle Harrison of Wellington (Firestorm Charities) and former state representative Glen Kolkmeyer of Wellington, whose company, Energy Transport Solutions, hauled the 911 memorial to Richmond for the event.

Regular meeting of the Board of Directors held Aug. 28, 2025

A meeting of the board of directors of West Central Electric Cooperative was held at the offices of the cooperative, in Higginsville, Missouri, at 9:30 a.m. Aug. 28, 2025, pursuant to the bylaws of the cooperative and previous resolution of the board of directors. The meeting was called to order by President Densil Allen Jr. Attorney Sheri Smiley caused the minutes of the meeting to be kept. The following directors were present: Allen Jr., Clark Bredehoeft, Richard Strobel, Dale Jarman, Robert Simmons, Stan Rhodes, Jeremy Ahmann, Colby Dowell and Elizabeth Houtsma. Also present was General Manager Michael

APPROVAL OF AGENDA

The agenda was approved as presented. APPROVAL OF CONSENT AGENDA

The board approved its consent agenda consisting of the minutes of the regular meeting on July 24, 2025; expenditures for the month of July 2025; new membership applications and membership terminations, and the Treasurer's

FINANCING AND TREASURER'S REPORT

Newland presented the August 2025 Operating Report (RUS Form 7) and Comparative Operating Statement. He reviewed the Financial and Statistical Report and Treasurer's Report with monthly and annual budget comparisons. He also gave the investment report. He presented and reviewed statistical data pertaining to operating revenue, expenses, margins, assets, liabilities, cash flow management, and KWH sales and ratios. He reported on interest rates, the impact of large loads on the budget and projections for August. He gave updated budget numbers. He reviewed investments. New services connected were reported on. The impact to margins from large loads was discussed. The financial reports were accepted as presented.

DISCUSS AND APPROVE CLOSURE OF F&C BANK ACCOUNT

Newland discussed a letter received by F&C Bank regarding an account with a low balance. The board approved closing the account.

APPROVAL OF STAFF REPORTS

The following staff reports were approved:

Operations Report
Operations Manager Scott Gard provided an oral report to supplement his written operations report. He reported on crews, expansions worked on, and outages and causes for the month. He gave a mechanic and fleet report including a school attended by the mechanic. He reported the mechanic has been very busy in the shop and they are considering hiring a part-time employee. A brush crew and ROW update was given. Damage to a truck caused by a pole falling on it was updated. An additional bucket truck was discussed. Currently the co-op is renting two bucket trucks. The cost of a new bucket truck is \$225,000.00. The board voted to amend the budget by \$225,000.00 for the purchase of the new truck.

Safety and Engineering Report: Engineering Manager Pete Nelson provided an oral report to supplement his written safety and engineering report. As of July 31, 2025, employees have worked 1,022 days without a lost-time accident. Co-op employees drove a total of 38,699 miles as of the end of July without a serious accident. He reported that the workers compensation MOD factor was just received and it is the lowest it has been since the year 2000. RESAP audits have been participated in. He reported on safety meetings, crew visits, and gave an engineering/staking department report. He discussed the Holden substation project. He reported on projects being worked on. He discussed the NW Wildfire Mitigation program and discussed a potential policy for moving the line for third party structures to go under. The policy committee will review for a

provided a written member services report. He provided updates on Operation RoundUp, the communication department activities and net metering. Chamber meetings and member surveys were reported on. The NISC bill redesign was discussed. A report on the state fair was given. Issues with solar companies giving false information that they are working with the co-op are circulating again.

Simmons and Newland gave the NW Report. They reported on the new manager search, new large loads, and updates on the Turney gas plant and AECI. The retreat in September will now be held on one day.

AMEC REPORT

Bredehoeft reported on the meeting held on Aug. 6. He gave departmental reports, updates on the Rural Missouri magazine, announced that Jim Bagley was elected as the NRECA representative and gave updates on training and development and grant writing for co-ops that is now available through AMEC. An AECI update was given.

CFC FORUM REPORT

The directors who attended the forum gave updates on the speakers.

ANNUAL MEETING REVIEW

Newland led a discussion on a wrap-up of the annual meeting. Comments from members were discussed. A total of 1,000 meals were served. Next year's annual meeting was discussed. The Policy Committee will look at a policy for allowing board candidates to speak at the meeting and how re-counts on ballots

REVIEW BOARD STANDING COMMITTEE ASSIGNMENTS

The board received the standing committee assignments for 2025 and 2026. Simmons will be removed from the Strategic Planning Committee and Ahmann will be added

Smiley gave the legal report for the month.

Newland gave the manager's report. He gave a staffing report. The salary committee will meet at 7:30 p.m. Sept. 15. The sick leave policy was discussed and changes were made to meet the state law requirements that go into effect Aug. 28. The Bates City franchise agreement was discussed. Annexations were discussed
