## Ackermann relives Honor Flight and time spent with co-op Youth Tour delegates in D.C.

In the early morning darkness, a bus pulled away and headed out of Sedalia, bound for Kansas City International Airport. This bus carried precious cargo -- 40 United States veterans excited and anxious to be a part of the Show-Me Honor Flight #17.

"It was incredible," WCE member Richard Ackermann, of Concordia, said of the June 2015 trip.

Upon arrival in Baltimore, the veterans were given a hero's welcome including water cannons, members of the military and a choir.

"They had one person from every branch of the service to greet us," Ackermann said.

"My guardian (Honor Flight members who are in a wheelchair are assigned their own host for the day) said I should look up some of my buddies I lost in Viet Nam," Ackermann said. "Well, it is really hard to do that because your mind just puts that out because they're gone, but he convinced me to go and look at the directory.

"We found two of them -- Nichols and Abernathy. He took out his phone and copied where they were on the wall. He pushed me over to Nichols, and it brought back a lot of memories. It was kind of tough," he said. "Then we went on down and found Abernathy, and I lost it; absolutely lost it. He said, 'That's all right. That's why we are here; to say goodbye and remember.'"

Ackermann said as he stared at the bottom of the wall and his comrade's

you go. And it helped me heal some; my anger against the Vietnamese."

Ackermann said after that, he could look at The Wall no longer.

"We had to get out of there," he said.

As they moved on to the other memorials in the area, a chance meeting with some outstanding cooperative youth made what Ackermann called an impression that he will long remember.

"We saw the Youth Tour kids at the World War II Memorial. So many of the them came up and thanked

us for serving and giving so much," he said. "It was heartwarming to know that teenagers cared so much. They all came up and the guys were all giving me handshakes and the girls were all giving me hugs and I think I spent 20-30 minutes just saying hello to them. They gave me hat pins and stickers that said their state on it. It was phenomenal."

After a long, hard day, the Honor Flight members were ready to head for

home. They returned to KCI around 11 p.m. and boarded their bus for Sedalia. The surprises weren't over, however.

"When we got to I-70 and 65 Highway, it was almost 1 a.m. and we were met by about 50 motorcycles including police and sheriff's department," he said. "They escorted us to Sedalia where there were people lined up and down Ohio Street at 1 a.m., elbow to elbow. It was absolutely

beautiful."

Ackermann said he believes every veteran should be able to see the memorials in Washington,

D.C. and is thankful to the Honor Flight program.

"It was incredible," he said. "The friendships you make with the others that went is just like you have another family. It was lightning to the heart."

## *2016 WCEC and State Technical College Electrical Distribution Systems Scholarship*

### **I. General Description**

West Central Electric Cooperative, Higginsville, Missouri, will accept applications from students interested in pursuing an Associate of Applied Science degree in Electrical Distribution Systems at Linn State Technical College, Linn, Missouri. This program provides for students a two-year scholarship in a quality college training program, a two-year college degree, and on-the-job training. General provisions of the scholarship are as follows:

### **II. Eligibility Requirements**

- A. Applicant should reside in the West Central Electric Cooperative service area.
- B. Applicant shall be expected to participate in an interview with the cooperative general manager and/or staff representatives in April of the application year.
- C. Applicant should be a student in good academic standing with a minimum 2.5 high school cumulative GPA, or GED with 260 minimum score.
- D. Applicant should be admitted as a full-time student to State Technical College, and be accepted into the State Technical College Electrical Distribution Systems Program.
- E. Applicant should attend Linn State Technical College commencing during the Fall semester immediately following receipt of the application.
- F. Applicant is required to complete a summer internship at West Central Electric Cooperative the summer semester between the first and second years of the academic program.

### **III. Selection Criteria and Award of Scholarship**

A. To be considered, applicants must forward a complete application by the scholarship application deadline of April 1, 2016. The criteria used to evaluate applications for award will be based upon the following:

- Academic achievement
- Civic involvement
- Leadership
- Ability to communicate clearly defined personal goals through personal goal statement (on application)
- Financial need
- Interview conducted by the general manager and/or cooperative staff

B. Selection Priority: This is a one-time annual scholarship awarded to full-time students attending State Technical College. West Central Electric Cooperative will determine the number of awards based on need and the number of applicants as well as the availability of funds. In the event a student is unable to fulfill the requirement of full-time enrollment for the fall semester in the year the scholarship is awarded, the scholarship may be transferred to the next available alternate.

C. Scholarship Award: The scholarship provides \$2,400 annually; \$1,200 is applied to recipient's account at State Technical College in the fall semester upon the student's verified enrollment. The scholarship may be used for the cost of tuition, fees, books, tools, and/or other costs associated with a student's education. The scholarship is renewable each semester if the recipient meets the continued expectations of the scholarship, up to \$4,800 maximum per recipient.

### **IV. Application**

Deadline for application to assure consideration for the next following academic year is April 1, 2016. Please submit the following to be considered:

- State Technical College letter of acceptance
- High school transcript, college transcript or official GED score report.
- Complete scholarship application, including personal goal statement.
- Two letters of character reference.
- Applications may be printed and mailed along with transcript or GED report and letters, or you may apply online at [www.westcentralelectric.coop](http://www.westcentralelectric.coop) under the heading "Youth Programs." If you apply online, please mail your high school transcript or GED score report and your letters of reference. Applications submitted via email must arrive by 4:30 p.m. April 1, 2016. Please also either email your photo as a .jpg to [heather@wcecoop.com](mailto:heather@wcecoop.com) or mail a photograph along with your transcript and letters.
- Applications may be mailed to West Central Electric Cooperative, Inc., Attention: Heather Hoflander, P.O. Box 452, Higginsville, MO 64037.

### **V. Expectations of Scholarship Recipient**

- A. Recipient must maintain 3.0 GPA per semester. There will be a one (1) semester probation should the student's grades fall below a 3.0 GPA. Failure to return to a 3.0 could mean loss of scholarship. Applicant will provide the cooperative with a transcript at the end of each semester.
- B. Recipient must attend all classes and work as scheduled. Excessive school attendance absences may result in suspension or termination of the remainder of the scholarship benefits.
- C. Recipient must comply with State Technical College's student policies and rules. Failure to abide by such policies and rules may result in suspension or termination of the remainder of the scholarship benefits.
- D. Recipient must contractually agree to work at West Central Electric Cooperative for four years following completion of the degree. A copy of the employment contract is attached as Exhibit A. The receipt of this scholarship is expressly contingent upon the successful applicant executing said employment contract, Exhibit A. Failure to complete the contract would mean reimbursement of the scholarship based on incomplete term. Employment after graduation will be solely at the discretion of West Central Electric Cooperative management. The employment contract may be changed or terminated at any time due to employee misconduct or if a position is not available.
- E. In the event the student initially awarded the scholarship is unable to fulfill the requirement of full-time enrollment for the fall semester, the scholarship may be awarded to the next available alternate.
- F. Release of Information: In submitting the application, the applicant grants permission for the scholarship committee to review high school and college transcripts and to contact character references. Submission of the application also grants permission to promote and publicize the scholarship and recipient(s).
- G. Recipient must submit an official transcript to West Central Electric Cooperative at the conclusion of each semester to verify eligibility and GPA.

### **VI. Winners' Notification**

Recipients of the scholarship will be notified by May 1, 2016.

## *2016 John & Kathryn English Memorial Scholarship*

### **I. Background**

The John & Kathryn English Memorial Scholarship Trust was created under the terms of the Last Will & Testament of Kathryn English. The purpose of this trust is to provide scholarship grants for high school graduates who are or were active 4-H members at the time of their high school graduation and who desire to attend college to pursue a degree. John English, a former director of West Central Electric Cooperative, Inc., designated West Central's Board of Directors as Trustees of the Memorial Scholarship Trust.

### **II. Amount of Scholarship**

The John & Kathryn English Memorial Scholarship Committee will award at least one \$1,000 scholarship (\$500 per semester) to a student beginning his/her freshman year in college. This student may reapply for additional grants for their next three years of study. The amount of these grants will vary due to availability of funds. The committee may decide to make one or more one-time scholarship awards based on merit.

### **III. Selection Criteria**

- A. The applicant will be selected without regard to sex, race, creed or color.
- B. The applicant must attend a high school in West Central Electric's service area, or have a parent or legal guardian who is a current West Central Electric member.
- C. A cumulative 3.0 or better grade point average is required.
- D. A minimum ACT score of 18 is required.
- E. Participation in 4-H at the time of high school graduation is required.
- F. Two reference letters are required. No letter may come from a relative, and one letter must be from an adult involved with 4-H (for example a project leader, a 4-H youth specialist, a county livestock specialist etc.)
- G. A high school transcript must accompany the application.
- H. The Scholarship Committee will consider financial need and special circumstances when selecting the winner of this scholarship. Please address financial need and any special circumstances when answering question # 5 on this application.

I. Please submit a recent photo along with your application. This photo will be used for press releases and for the WCE newsletter if you are selected a winner. Winners who have not included a photo with their application will appear as "photo not available" in all publicity materials.

J. Finalists will be required to participate in an interview with the scholarship committee.

K. All scholarship applications MUST BE TYPED.

L. High School counselor must sign your transcript. (Home school transcripts are accepted, but must be signed by the teacher.) \*\*Applications received without transcripts WILL BE PENALIZED.

M. All of the above requirements, except item I, must be met for an application to be considered

### **IV. Restrictions**

Children and grandchildren of current WCE directors are not eligible to apply.

### **V. Application Deadline**

Also present were General Manager Mike Gray and Shawn Battagler, general counsel.

**APPROVAL OF AGENDA**

After discussion, the agenda was approved as amended.

**APPROVAL OF MINUTES**

The unapproved minutes of the regular meeting of the board of directors held Oct. 29, 2015 were approved.

**REVIEW OF EXPENDITURES FOR OCTOBER**

An itemized list of expenditures for October was presented to the board, and the payment of the bills was ratified.

**APPROVAL OF REPORTS**

## Why keep power lines in harm's way?

High winds and icy conditions can cause tree limbs to fall on power lines, triggering outages. Although West Central Electric linemen are on call around the clock and respond quickly to problems, some folks ask a simple question: Why keep power lines in harm's way?

There are two ways electricity can be delivered to a home: through overhead or underground power lines. Although underground lines may seem attractive during storms since the lines are not exposed to extreme weather, the technology doesn't always make sense for electric cooperatives focused on affordability. In some states, for example, installing power lines underground costs double the amount per foot compared to overhead.

Most underground lines nationally are found in subdivisions where developers request and pay for the option for aesthetic reasons or to comply with local statutes. A high concentration of homes in these areas helps spread out the expense. But the bulk of the nation's cooperative energy (including that provided to subdivisions) continues to be delivered via overhead lines—16 percent of the 2.5 million miles of distribution lines owned and maintained by electric co-ops across the nation are found underground. Cooperatives are not-for-profit, selecting distribution methods with two goals in mind: keeping electricity affordable and reliable for consumers.

There are pros and cons to both forms of power distribution. For instance, underground facilities are more reliable during storms and generally require less right-of-way maintenance because there are no trees, brush, and other vegetation to clear away.

However, faults in underground power lines are not easy to track down and fix. Studies comparing the increased cost of underground lines against their benefits showed underground savings did not outweigh the heavy initial cost of installation.

"If a tree falls on a line, you can normally drive down the line, see the problem, and get to work restoring power," said Operations Manager Randy Burkeybile. "The same holds for repairing broken insulators and crossarms—if you see it, you can fix it. But underground lines are tough to troubleshoot. You can't find a problem with your eyes — you have to search harder for it, tracking it down based on where the power flow stops. Then a line crew has to dig a hole to reach the spot before repairs can be made."

For most cooperative consumers, affordable overhead lines will remain the norm, at least for now.
